



## Terms and conditions for marketing in DWBM shopping website

**This agreement covers in triangle way three personals:**

**The buyer:** is the person who wants to pay any product listed in our website, in the category (general products).

**The Seller:** is the person who accepts to have his product(s) displayed in our shopping website.

**DWBM SHOP:** is the website playing the role of online shop where people can sell, buy and market their products. The shop is owned by Daniel Web-Builders and Marketing cc ( DWBM).

## Membership

The buyer as well as the seller can be member of this shop [www.sces.biz/pay](http://www.sces.biz/pay) provided to accept the terms of this agreement.

### 1-Responsibility

1.1-DWBM will not be responsibility for any loss of money before, during the transfer by the buyer into our account once we have not received the proof payment.

1.2-DWBM will not be responsible for any loss of money after the transfer of the fund (received from the buyer) to the seller, as far as, there is a proof of transfer to the seller.

1.3-DWBM will not be responsible for the delivery of goods to the buyer.

1.4-DWBM will not be responsible for the condition of goods sold good or bad.

1.5-DWBM is only acting as a marketing company to ensure that goods are displayed or marketed in our website.

### 2- Transfer to the seller by DWBM

2.1-The money can only be transferred by DWBM to the seller when the buyer has finally approved the product and the delivery policy of the seller.

The buyer must then confirm the acceptance of the product he would like to pay.

2.2-If the buyer does not approve of the product and delivery policy of the seller, the money will be re-transferred to the buyer or DWBM can find another seller to satisfy the buyer.

### 3-Refund policy

3.1-The money can be refunded to the buyer if it has not been transferred to the seller.

3.2-The transfer fee will be deducted when refunding the money to the buyer.

We use only two methods of transfer for the moment to refund the money:

Bank transfer and Moneybookers

### 3.3- Duration of transfer

\* Moneybookers : same day

\* Bank transfer will take 1 week

### 4- Payment methods useful to the buyer

The buyer will use one of the payment methods listed in the online shop ( [www.sces.biz/pay](http://www.sces.biz/pay) )

### 5- Fraud Alert

5.1-DWBM will never protect or cover fraud; we reserve the right to help the client in claiming his right once the money has been transferred to the seller.

5.2- We reserve the right to suspend, block any transaction and report to the authority when the buyer has used a stolen credit card to purchase any product.

5.3- DWBM declines all responsibilities that may occur during the transaction between the buyer and the seller. This is applicable once the money has been transferred to the seller.

5.4-DWBM reserves the right to cancel or suspend any shop member.

### 6-Conditions of membership

#### 6.1- Seller

-The Seller must accept and sign this agreement at the bottom of each page.

-The seller must sign a membership form that will be sent to him.

-The seller must send the copy of this agreement to the buyer, he should be informed.

-The seller must have a Moneybookers account or any bank account in South Africa.

#### 6.2- Buyer

-The buyer must read this agreement before shopping in general products ( shop member category)

-The buyer must be freely member of our online shop ( [www.sces.biz/pay](http://www.sces.biz/pay) ) before any purchase.

### 7- Updates

DWBM reserves the right to update at any time this agreement. Notification will be sent to shop members 15 days before the effect of changes.
